Minutes of the General Meeting of 6th February 2013

5. Moved Cassandra Brown seconded Lance Haslewood that the minutes of the general meeting of the 5th of February 2013 as presented in the February Newsletter be accepted as true and accurate record of the meeting.

Business Arising from the Previous Minutes

7. The Acting Secretary presented the inwards correspondence for the month of February 2013 but advised there was no outwards correspondence.

Treasurer's Financial Balance of Accounts

Swap Meet and Show 'N Shine, 22 June

10. Banners. Have received approval from the Moreton Bay Regional Council to erect banners at Caboolture Lakes and at Woodford two weeks prior to the event. Steve and Darryl have also offered to have a banner placed at their houses to give greater exposure for the event.

11. Cathy to arrange to have the banners updated to reflect the 2013 event and than distribute accordingly.

12. Club Car Display, Morayfield Shopping Centre. Lance has offered to provide his DeLorean for display in the Morayfield shopping Centre to help advertise and showcase the event. Volunteers needed on-site while car is at the shopping centre. The dates are 13, 14 and 15 June.

13. Club Public Liability Insurance. Club insurance has been increased from \$10 million to \$20 million to cover having the car at the shopping centre and also for the swap meet.

14. Insurance Cover for Pick-Up Vehicle. Pick-up vehicle for the swap meet is not covered by the club



public liability insurance. Have been asked if a club member would like to use their ute for delivery of parts etc for the swap meet.

15. SES Assistance. SES have been contacted to see if they are available to assist with the swap meet again. Waiting on confirmation after they have held their meeting.
16. Illuminated Signs. Cathy has asked to see if the Club can again get illuminated signs. Kevin will look into it with Master Hire to see how much it will cost. Darryl also to see if his boss will sponsor the cost of a sign again.
17. Printing of Flyers. Brian Bates from Caboolture Bowl has printed over 4000 flyers for the swap meet and show & shine for the club. Cathy has asked that he receive some recognition in the newsletter for doing it.
18. Food Vendors. Food or coffee vans wanting to be part of the show & shine and swap meet must have all the relative licenses and insurances otherwise they will not be permitted to partake.
19. Show & Shine Trophies. Kevin Lewis and Cassandra Brown to start to organise the trophies and determine a provider. Action Trophies at Burpengary was suggested.
20. Event Sponsorship. The Club has received lots of sponsorship offers as a result of the letters which have been sent out. Will now be sending out thank you letters and a free entry into the show & shine to those who have sponsored the event.
21. Club Decals. Lance has been looking into a new supplier of stickers for the club. This is ongoing at the moment. He would like some minor changes done in that the colour of the club name be changed from black to white and the web site address added.

Runs/Reports.

22. Sunshine Coast Run, 24th February. Last months run to the Sunshine coast was a good day. Thanks again to Liz and Darryl for supplying morning tea. The weather stayed away which was great.
23. The Spit, Gold Coast, 24th March. Next run to be on 24th of March to The Spit at the Gold Coast. Meet at BP South at 8:00am for an 8:30am departure.
24. Review of Run Departure Point. Lance brought-up the point that leaving from the Sundowner was extremely difficult due to the difficult exit and the traffic lights. He proposed the Club move the meeting points back to the BP's. This was seconded by Carl Talboys and passed.

Special Interest Vehicle Registration (SIV) ~ 'Concessional' or 'Club Rego'

To qualify for 'Concessional' or 'Club Rego' registration, new members must attend four (4) Club-sanctioned activities or Club meetings within the first six (6) months of membership. Thereafter new and present members holding concessional registration must attend four (4) Club-sanctioned activities or Club meetings each year in order to retain the concessional registration. Failure to comply may result in a recommendation to the Department of Transport and Main Roads for forfeiture of the registration.

Some facts for Special Vehicle Registration:

Registering your vehicle under the Special Interest Vehicle Registration Concession Scheme:

Historic Vehicles

You will need to follow the standard registration procedures for a vehicle as well as completing a Vehicle Registration Concession Application (form F3937) and providing the following documents as proof of eligibility:

Club Membership: Evidence of current membership with an incorporated vehicle club or association must be provided at the time of application for the concession.

Historic Vehicle and Dating Certificate: A dating officer (or club official) of an incorporated vehicle club or association must inspect the vehicle to certify the vehicle's authenticity and year of manufacture, that is, no structural modifications have been made that would deem it as manufactured at the date it was modified. This certificate must be on club letterhead or other official club documentation and include the chassis number or vehicle identification number.

Vehicles fitted with a modification plate, code LH10 are not eligible for a special interest vehicle concession.

Vehicles registered under the scheme have certain limitations placed on their use. This is reflected in the reduced fees and compulsory third party insurance premium. Registered operators must confine their vehicle's use to:

- Participating in rallies organised by incorporated vehicle clubs.
- Participating in processions for which a Special Events Permit has been issued under the Transport Operations (Road Use Management –Accreditation and Other Provisions) Regulation 2005.
- Exhibiting the vehicle in displays, fetes or similar functions conducted for religious, charitable or educational purposes.
- Ceremonial purposes (weddings, formals) involving immediate family members provided this is not done for fee or reward. Immediate family means parents, grandparents, sons, daughters, grandchildren but not extended family relationships such as nephews and nieces.
- Preparing for, proceeding to, and returning from the above activities.
- Direct travel to and from an Approved Inspection Station (AIS) for the purposes of obtaining a safety certificate before offering the vehicle for sale.
- Travel in order to have the vehicle repaired. There is no distance restriction in these circumstances however, such travel must be reasonable and justifiable by the vehicle operator.
- Road testing within a 15 kilometre radius from the place where the vehicle is garaged. The purpose of the travel must be to road test the vehicle following repair or restoration and not for any other purpose. This does not include use as a means of transport.

Failure to comply with the conditions of the special interest vehicle scheme is an offence and serious consequences may result.

Car Enthusiasts Unite !!

Late last year there was a flurry of online activity regarding the proposed Police Powers & Responsibilities (Motor Vehicle Impoundment) and Other Legislation amendment Bill 2012 (from now on referred to as "the Bill"). This is the Act which the "anti-hoon" laws fall under in regards to hooning activities and vehicular impoundment or forfeiture.

The Bill was tabled in to QLD Parliament in November 2012 and members of the public, special interest groups and legal groups were invited to submit their own objections to the Legal Affairs and Community Safety Committee prior to 4 Feb 2013.

As a result of the level of objection shown in the submissions the Bill went before a committee briefing in QLD Parliament on 13 Feb. The briefing gives the committee the opportunity to question the Queensland Police Service (QPS) on various aspects of the Bill so they can seek a better understanding of what the QPS is proposing before the Bill goes before Parliament to be voted on. This is where we are at now.

The amendments to the Bill are many but in short they add up to severe penalties for hooning offences and they give the QLD Police Service more power to enforce the anti-hoon laws without the requirement for offences to be heard in court first. All of this is to fulfil Campbell Newman's election promise of introducing "the toughest anti-hoon laws in Australia" and to streamline QPS procedures to save time and money. There is very little evidence that this Bill has anything to do with improving road safety. The fact that several high ranking Police Officers have stated the Bill is designed fulfil an election promise and that when deciding the penalties the QPS took bits and pieces of other states legislation and rolled it up into their own Bill suggests that not much, if any, research has gone into the effect the Bill will actually have on road safety and reducing the incidents of hooning.

It is about now that I can hear you asking yourselves "Im not a hoon, I don't do burnouts, so why should I be concerned. After all, if you don't do anything wrong you have nothing to worry about. Right?" Unfortunately that type of thinking is exactly what the politicians and advocates for the Bill are relying on to get this rubbish passed. I can assure you, with 100% confidence that you DO have something to seriously worry about. I would find it extremely difficult to find a car in our club that has not been modified. Keep that in mind as "illegal modifications" come under the Type 2 related offences. Get caught once with an illegal modification and you enter the scheme (vehicle not impounded). Second offence and you lose your car for 7 days, 3rd offence its gone for 90 days and 4th offense say good bye to your pride and joy for ever. The problem here is that it is not a qualified engineer with access to tools, knowledge and experience who determines if your car is illegally modified, but it's a Police Officer. A Police Officer with potentially no mechanical knowledge and experience, inspecting your car with a torch on the side of the road can decide if your car is illegally modified.

Doesn't sound very fair to me and it doesn't seem very fair to the Police Officers who are tasked with enforcing a grey-area law. Despite the fact that your car meets and/or exceeds modification requirements, is 100% legal and is driven responsibly, the determination of whether a modification is legal or not comes down to the Police Officer conducting the inspection. NOT FAIR !!

Okay, so have I got your attention now? I sincerely hope so.

Please note, this is not about "Us v Police". Some of you are members of the QPS and you do an outstanding job (one that I wouldn't like to do). This is about "Us v Reckless Legislation". The Police Officers are tasked with enforcing the law and it's not their fault the law is so open to interpretation. I would like to think that all QPS staff would exercise a sensible approach and consistency in enforcing these laws but as we all know, most Police Officers are fair and reasonable, but not all.

In an effort to protect ourselves from such Draconian legislation the QTCC members have agreed that we need to get behind a campaign to stem the flow of "Hoon Hysteria" that is being propagated by media, Government and public ignorance. We need to educate and engage with these folk to get the message across that Car Enthusiasts and Hoons are not one and the same. Watch any report by A Current Affair that involves hooning and you will hear "Car Enthusiast", "Rev Head", "Petrol Head" and "Hoon" all used in the same sentence and in the same context. Clearly they do not see (or want to see) a distinction between the groups. You and I both know the difference, but Joe Public who hears a rumbling V8 cruise past his house doesn't. And Joe Public has access to numerous "Dob in a Hoon" avenues. The point here is that if the public don't know the difference, we are in trouble.

So the QTCC has got behind Grunt Files and Australian Confederation of Motor Clubs to show the masses that we are not Hoons and that we have a right to enjoy our cars and our hobby without fear of victimisation, targeting and discrimination. We are desperately trying to have our concerns heard by the State Government and unfortunately, thus far, our concerns are falling on deaf ears or are simply being played down. I can quote many examples of this but I don't have enough hard drive space on my computer to quote them all ☺

I have so much to say on this topic however most of what I have to say is already documented online for you to refer to. I urge you all educate yourselves on this matter, after all, this affects you as much as it affects me. As Grunt Files are the primary advocate for us in QLD please visit <http://www.gruntfiles.com> click the link up the top of the page titled Campaign and then use the links on the left to navigate through various aspects of the Campaign. You can also Donate to the Campaign as the work that is being done is so far funded from Keith and Sharyn Littlers own pockets and they need our help. I also urge you to "Like" the Grunt Files Facebook page and have a read of the posts Keith and Sharyn are putting up. They are well written, insightful, and relevant to our cause.

If you can't be bothered reading, go the recently revamped (by me ☺) Grunt Files youtube channel and watch the speeches from the recent APMC 2013 Motor Enthusiast Conference. Geoff Seddon (Street Machine), Alan Hay (NSW National Party Executive), The Hon. Duncan Gay MLC and others all have extremely worthwhile speeches to listen too. There are many ways you can show your support and get behind this. The first thing you need to do however is be aware of what is going on. Dear Mr Standfield

Thank you for your letter of 16 November 2012 about Queensland's hoon laws. I apologise for the delay in responding.

In the lead up to the election, I promised Queenslanders that we would put the brakes on hoons by introducing the strictest anti-hooning laws in the nation. I believe the Government was given a mandate to do exactly that by a significant majority of the population. I can see that you disagree with the laws and, while I can understand your point of view, I make no apologies for delivering on our election promise.

However, I would like to make it clear that this anti-hooning legislation is not about attacking the livelihoods or lifestyles of legitimate car enthusiasts. It is about making sure that people who commit offences, or pursue conduct that is offensive and dangerous, are kept in line for the community who are entitled to enjoy their lives in safety and peace.


I note your comments about the word 'hoon', however, I think that most people would recognise that 'hooning' relates to the antisocial and illegal behaviour exhibited by people, rather than being meant in any discriminatory way.

I should also mention that I believe it is important that members of the community have their say. You may not be aware that most Bills, before they become law, are referred to a bipartisan Parliamentary Committee for consideration. Members of the public can make written submissions to the committee and can also appear at public hearings to provide their views on the law, as well as practical information about how the proposal will affect them.

The Police Powers and Responsibilities (Motor Vehicle Impoundment) and Other Legislation Amendment Bill 2012 (the Bill) is intending to make changes to the hooning legislation. The Bill was recently referred to the Legal Affairs and Community Safety Committee (LACSC) — one of the bipartisan Parliamentary Committees referred to above. If you would like to have your say on the Bill, the committee is due to report back to Parliament by 12 March 2013 and will be taking submissions until 1 February 2013. Thank you for sending me your concerns regarding the Governments responses to Hooning.

I am pleased let you know that the Government is serious about getting tough on hooning and anti-social behaviour on our roads. As a car and motorbike enthusiast I understand your concerns, however the Queensland Government was given a mandate to tackle hooning.

Serious offenders will have their cars impounded for three months and a second serious offence in five years will see the offender's car sold or crushed.

This government has also established a hooning hotline that residents can call if they experience hooning in their local area to ensure a rapid response to dangerous driving and hooning activity.

These tough measures are in response to community expectations and are designed not to take away from the legitimate rights of any group to drive legally modified or classic cars.
