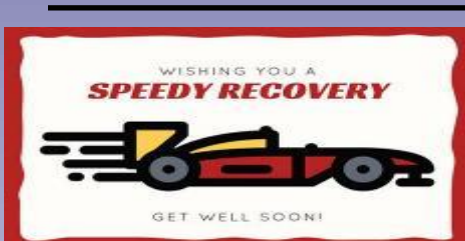

A statement of duties for Management Committee Positions are as follows:

☐ **President:** Responsible for fulfilling the Club Mission by leading the Club Executive Committee and ensuring that the Club Objectives are met.

☐ **Vice President:** Responsible for assisting the President and Secretary to fulfil the Club Mission and other activities of the Club as directed by the President.

Performs the duties of the President and/or Secretary if they are unable to do so.

☐ **Secretary:** Responsible for initiating, recording and maintaining the Club hardcopy records including, minutes and correspondence.

☐ **Treasurer:** Responsible for the collection, custody and payment of all Club accounts, and for the correct maintenance, recording and reporting of the details of these activities and transactions.

☐ **Membership Officer:** Responsible for the maintenance of the Club membership records, administration of membership-related tasks and ordering and procurement of regalia and merchandise.

Experience with Microsoft Access a definite advantage.

☐ **Editor:** The Editor is responsible for the compilation and distribution of the monthly newsletter to financial members. Experience in Microsoft Word and Publisher an advantage.

☐ **Run Coordinator:** The Run Coordinator has overall responsibility for all Club runs, and in particular, the development of an advance club runs calendar.

☐ **Club Dating Officer (Special Interest Vehicle Scheme):** Responsible inspecting vehicles to ensure that they comply and meet the requirements of the Department of Transport and Main Roads to be eligible for registration as 'Special Interest Vehicles'. The Club Dating Officer must maintain a register of Club special interest vehicles and ensure that the Club obligations of holders of such vehicle registrations are fulfilled in accordance with Club Rules.

☐ **Show, Shine Coordinator:** Responsible for coordinating the Club's yearly show, shine event and liaising with relevant authorities.

- Workshop Coordinator:** Coordination of DIY workshops.
- Christmas Function Coordinator:** Coordinate the Club's yearly Christmas function.
- Catering Convenor:** Setup the monthly meeting supper service. Procurement of relevant consumables.

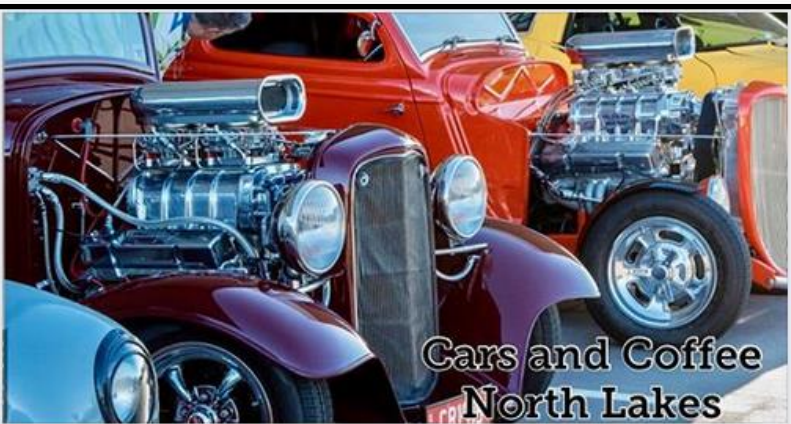

RUN ETIQUETTE

To ensure that their vehicle has adequate fuel to reach the destination or the next planned fuel stop. Refuelling the vehicle should be done before refuelling oneself! Run departures will not be delayed for those vehicles needing last-minute fuel particularly if there has been an ample opportunity to fill-up before the run departs.

Urged to be on time for the commencement of the run and/or event. Should a member be running late and wishes to commence the run with the group, he/she should contact the run coordinator. Similarly if members wish to join en-route.

Urged to keep together wherever possible, particularly in built-up areas. This will minimise the necessity of continually stopping to regroup which can be hazardous. It is realised that keeping together in built-up areas can be difficult, but often those caught at traffic lights will catch-up to those in front as they themselves are slowed by lights.

Not permitted to overtake the designated run leader. However participants may move about within the group, overtaking when safe and legal.

Encouraged to remain with the group until the agreed dispersal point at the end of the event. This also applies to static events such as car shows.

Encouraged to carry a small portable UHF CB radio and set to Channel 9. Such radios are relatively inexpensive, and have ranges varying from around one to five kilometres. They are invaluable and a medium by which to keep informed about what is going on, and to let the group know if you have become separated or broken-down.

– **John Dickson** made a request that given the Club would not receive a tax benefit from donations to charity groups that were not registered the Club should only make donations to Registered Charities. **Lance Bower** asked if taxation benefit was the reason why we gave donations in the first place to which the members gave a resounding response of no. **Kevin Lewis** said this had never been a consideration when donations were commenced years ago. **Olive Jones** said while it was good to get the tax advantage from donations most Registered Charitable organisation were large organisations, many based outside the Caboolture area, and while they may help people within the Caboolture Area this was not always visible to us. She went on to say that the small groups we had supported in the previous couple of years did work within our community that was very much 'hands on' within the community. She also advised the Club now had in place a formal application process and each nomination for support was given due consideration by the Management Committee. **John Rodgers** asked why this topic was even up for discussion given the recent changes to the By-Laws whereby all donations had to be approved by the members. This ended the discussion on the topic.

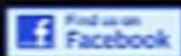
